

**GP Enforcement Services First Quarter Report - 2021** 

## Highlights

- The Vehicle for Hire Bylaw C-1394 was finetuned to modernize the City's approach to the vehicle-for-hire industry. Set for implementation on May 1, 2021, this bylaw introduces new licensing requirements and regulations for previously unregulated services operating within the municipality with the goal of ensuring public safety, consumer protection, accessible vehicle-for-hire services, fair competition and open innovation within the industry.
- GPES continues to liaise daily with Community Social Development, the Mobile Outreach Program, Rotary House, and St Lawrence Centre with the goal of reducing the impact of homelessness within the City. Our department has assisted these initiatives targeted at vulnerable street engaged persons, making it possible for them to connect with the appropriate social services and resources suited to meet their needs. Our dedicated team of Enforcement Officers have also had occasion to administer lifesaving Naloxone to counteract deadly opioid overdoses they have come across during their patrols.
- GPES is moving forward with preparations for the Administrative Penalty Information System (APIS) project that is currently in development as part of the Justice Transformation Initiative (JTI) through the Solicitor General of Alberta. We are in the process of updating our modems and printers within the patrol vehicles to allow integration into this provincewide initiative for the implementation date of December 2021.
