SUBJECT: Access to Information and Protection of Privacy Bylaw C-1382 and Policies			

RECOMMENDATIONS

Committee recommend Council give three readings to Bylaw C-1382, being the Access to Information and Protection of Privacy Bylaw and approve Policies 500 (Access to Information and Protection of Privacy) and 807 (Video Surveillance), as presented.

Committee recommend Council repeal Policy 805 (Video Surveillance in Public Areas) and Policy 806 (City Facilities Video Surveillance).

PREVIOUS COUNCIL / COMMITTEE DIRECTIONS

There are no previous Council or Committee directions related to this item.

BACKGROUND

In February 2017, the City received the results of a Gaps Analysis Assessment conducted by Cenera on our information management standards including protection of privacy practices in compliance with the *Freedom of Information and Protection of Privacy Act, RSA 2000, c. F-25 (FOIP Act)*.

Cenera reviewed the City's overall information management standards, policies, processes and overall performance using existing information to identify key functions, activities and sources for gathering detailed process information. Interviews and site visits were conducted to determine how personal information was collected, used, disclosed, retained and secured.

From the data collected, Cenera developed a comprehensive and usable Assessment Report identifying gaps, and provided recommendations with actions to address the exceptions to compliance.

ANALYSIS

The FOIP Gaps Analysis report provided detailed step-by-step recommendations to address:

- Accountability and Transparency;
- Policies and Procedures:
- Communication, Training & Awareness;

- Internal/External Forms;
- Photos and Surveillance;
- Employee Information Privacy;
- Consent Standards:
- Authorized Representatives;
- Information Management & Retention;
- Personal Information Banks;
- Safeguards & Security Breach Response;
- Individual Access & Correction of Personal Information;
- Active Dissemination & Routine Disclosure:
- Privacy Impact Assessments (PIA's); and
- Research

Although the findings of the gaps analysis assessment revealed a well-managed organization, operating under privacy practices that are, for the most part, already compliant with the FOIP Act, the report presented the following identifiable gaps:

- Minor security risks within physical offices and day-to-day operations;
- Employee awareness and training;
- Current Bylaw contains outdated references to Provincial Legislation;
- Current records management policy that does not support the FOIP Act or provide for the retention and destruction of records;
- Internal and external forms lack consistency in the use and accuracy of a FOIP Collection Notice:
- Non-compliance with the FOIP Act regarding Personal Information Banks;
- Lack of a Security Breach Response policy and process;
- Non-compliance with the FOIP Act regarding support to individuals seeking corrections to their personal information; and
- FOIP information webpage on the City's website.

Actions to Date:

Since 2017, Administration has initiated several projects to address the FOIP Gaps Analysis report. Some of these initiatives include:
