Overview Notes and Caveats:

Crime incident information was gathered for the years 2019 to 2022 for the location of the Stonebridge/Community Care Campus Site (12102 100 Street Grande Prairie), the wider neighbourhood which encompasses the Stonebridge/Community Care Campus Site (Northridge Neighbourhood), and the neighbourhood immediately adjacent to east (Northgate East Neighbourhood).

Unless otherwise noted, all crime statistics in this report were compiled using the "All Violations" methodology. This approach measures only the most serious offence related to an incident.

Not included in this report are incidents classified as "Unfounded", "Unsubstantiated" or "Cleared (Non-Criminal)" as well as all provincial traffic infractions.





