# PREVIOUS COUNCIL / COMMITTEE DIRECTIONS

On May 23, 2023, Committee made the following motion: "Committee direct Administration to bring back a FireSmart report to Council for consideration, including areas of need, residential covenants, and naturalization, as well as any other pertinent information."

### **BACKGROUND**

City Administration is submitting two applications to FRIAA. The first application is to conduct vegetation management in the Bear Creek Corridor as recommended in the Grande Prairie Wildfire Mitigation Strategy: South Bear Creek 2019. The second application is to provide public education on the FireSmart Program, including a FireSmart home assessment initiative.

Part of the application process requires a motion of Council showing support for the application(s).

Wildfire Mitigation ensures Quality of Life, Safety and Security for residents and visitors.

# **Social Impact**

Wildfire Mitigation in the Bear Creek Corridor helps promote an active lifestyle in our Urban Park.

## <u>Risk</u>

Wildfires create a risk for structures and residents living near Wildland Urban Interface (WUI).

## STAKEHOLDER ENGAGEMENT

Several City Departments have been actively engaged in the prevention of wildfires in the Bear Creek Corridor. With the grant funding, City Administration will engage with all interested residents in teaching FireSmart Program concepts.

### **BUDGET / FINANCIAL IMPLICATIONS**

FRIAA requires applicants to contribute financially to the expenses of approved projects. The contribution can be financial and/or through gift-in-kind. Approved grants can be up to the amount of \$200,000.
