SUBJECT: 2025 Policing Services Budget and 2026 – 2028 Policing Services Projections

RECOMMENDATIONS

That Committee accept this report and refer to budget deliberations.

PREVIOUS COUNCIL / COMMITTEE DIRECTIONS

On March 20, 2023, Council passed three readings of Bylaw C-1455 which formally established both the Grande Prairie Police Commission ("Commission") and the Grande Prairie Police Service ("Police Service").

BACKGROUND

As outlined in Section 29(1) of the Police Act, the Commission, in consultation with the Chief of Police, is required to prepare estimates of all money required for the financial year to pay remuneration of the police officers and other persons employed for the police service, and provide and pay for the maintenance of accommodation, equipment and operating costs of the police service, and shall submit those estimates to Council along with the yearly plan of services and programs. On January 1, 2024, Municipal Enforcement Services, Mobile Outreach, Policing Operations Support and the RCMP contract were moved to the Police Service budget therefore becoming the responsibility of the Commission.

On July 18, 2024, at their regular meeting, the Commission approved the 2025 Policing Services Budget as well as the 2026 – 2028 Policing Services Projections for submission to Council.

ANALYSIS

The role of Policing Services is to utilize best practices, innovative approaches, community engagement, consultation, and partnerships to collaboratively address public safety and complex social concerns. The police officers, peace officers, outreach workers, and civilian employees employed in Policing Services are dedicated to enhancing the quality of life for the residents of

Grande Prairie. The 2025 Policing Services operating budget will have a net cost \$34,609,448, \$36,395,772 for 2026, \$35,530,553 for 2027, and \$37,422,696 for 2028. Capital funds required for 2025 will be \$2,123,000, \$2,103,000 of those costs will be covered by the transition grant. The \$700,700 Capital projected for 2026 and the \$571,800 Capital projected for 2027, will also be covered by the transition grant.

The Grande Prairie Police Service is building a modern, professional, and locally accountable police service that will enhance public safety within the city. During the transition, policing services are delivered by Grande Prairie Police Service and RCMP officers. Once the transition is complete, Grande Prairie will be policed solely by the Grande Prairie Police Service. Key budget items for 2025 include strategic planning, policy development, equipment acquisition, IT system design, as well as officer recruitment and training. It is anticipated that in 2025, approximately 18-20 Experienced Officers and 26 new Recruits will be hired, trained and deployed.

Enforcement Services provide municipal law enforcement in an amalgamated environment with the Grande Prairie Police Service, RCMP, and Mobile Outreach. They are responsible for enforcement of municipal bylaws, provisions of the Municipal Government Act, and various Provincial Statutes. Their mandate encompasses: bylaw enforcement, animal control, parking control, traffic enforcement, community engagement and public safety, as well as vehicle for hire licensing. Enforcement Services strive to deliver an educational approach to bylaw enforcement and traffic safety whenever possible.

Mobile Outreach is a diversion program focused on mitigating the impacts of street level disorder, addiction and public intoxication. They assist business and residents in handling their concerns related to the street engaged population, which may include trespassing, loitering, disturbances, public intoxication, needle debris and encampments. This program is intended to provide immediate support for client's basic needs and navigation through local service systems.

Policing Operations Support are the municipal employees at the RCMP Detachment providing operational and administrative support to front-line policing services. These essential public safety and security services include crime data and statistics, court liaison duties, cellblock guarding, CPIC entry, processing criminal record checks, call taking, and dispatching.

RCMP Contracted Services, in 2025 the RCMP remains the Police Service of Jurisdiction and continue to provide the frontline services essential to promote public safety and security for Grande Prairie residents.

BUDGET / FINANCIAL IMPLICATIONS

The 2025 Policing Services operating budget will have a net cost to the City of Grande Prairie of \$34,609,448 and projections of \$36,395,772 for 2026, \$35,530,553 for 2027, and \$37,422,696 for 2028. Capital tax costs of \$20,000 are budgeted for 2025. The municipal policing transition budget continues to be covered through the Public Safety and Emergency Services Ministry grant.

SUMMARY / CONCLUSION

The Grande Prairie Police Commission has approved the 2025 Policing Services Budget along with projections for 2026 – 2028 and is recommending Committee accept the report and refer to budget deliberations. As Grande Prairie Police Service builds up, and the RCMP contract winds down through the transition, service levels are anticipated to increase while costs remain consistent.

GRANDE PRAIRIE POLICE COMMISSION

Overview

In accordance with the Police Act (Alberta) and the Grande Prairie Police Commission Bylaw (C-1455) the Grande Prairie Police Commission (GPPC) is the civilian policy making and oversight body for the Grande Prairie Police Service (GPPS). The GPPC includes five appointed public members, two city councilors and two provincial appointees. The GPPC is supported by an Executive Director (ED).

The GPPC is responsible for ensuring that the police service operates in a manner that is accountable, transparent, and aligned with the needs and expectations of the community. The GPPC is also responsible for forming and overseeing the establishment of policies and guidelines for effective and efficient policing, appointing and evaluating a Chief of Police, collaborating with the Chief of Police to set priorities, ensuring sufficient staffing, designating a Public Complaints Director, and allocating funds provided by City Council.

ENFORCEMENT SERVICES

Renovations to Animal Pound

Capital Tax - 2025 - \$20,000

The Grande Prairie Regional Animal Pound requires minor renovations to enhance the building's functionality. The proposed renovations include replacing an overhead door with a lower wall section and an upper glass portion. These renovations are essential as the current service bay is no longer used for its original purpose and now serves as the main public entrance. Additionally, the long-term plan involves converting part of this area into office space due to a current shortage. This transformation cannot proceed without removing the overhead door and installing a wall. The Regional Animal Pound is financially supported through a 60/40 split with the County of Grande Prairie. The County, who operates the pound, has requested that the City fund this project in 2025 to facilitate the necessary renovations.
