5.1 Service Area Update

- B. Glavin, Chief Operating Officer, presented Committee with an update on the current and projected activities planned throughout the service area:
 - Engineering & Transportation Services Nightshifts are underway for potholing of arterial intersections to minimize traffic disruptions. The following have been posted: RFQ 2025 Concrete Grinding; and Crystal Lake Tree Planting project in

partnership with FRIAA. There are many ongoing construction projects across the City.

- Corporate Facility Management The Bonnetts Energy Exterior Door Replacements project is nearing completion. The South Entrance Exterior Concrete Slab replacement at Eastlink Centre is scheduled for July 14. The Centre 2000 Sundial Brick Remediation project has been awarded.
- Environment & Parks Regular maintenance continues across the City. Spring tree planting of 263 trees is now complete with more to come in the fall. The Integrated Pest Management crew is focusing on weed control in medians and other hard surfaces within the City.

5.2 <u>SureCharge EV Charging Station Lease Term Extension</u>

M. Phillips, Director of Corporate Facility Management, presented Committee with information regarding a potential lease extension with SureCharge.
